UNCLAIMED \$1 MILLION MEGA MILLIONS® TICKET EXPIRES JAN. 25

Winning ticket was purchased in Prairie View for the July 29 drawing

AUSTIN – A second-tier winning ticket worth \$1 million for the Mega Millions drawing held on July 29 is getting closer to expiring. The Quick Pick ticket matching five numbers drawn was purchased at Fuel Maxx #47, located at 420 University Drive in Prairie View, but the \$1 million prize has not been claimed.

The winning ticket matched all five of the white ball numbers drawn (13-36-45-57-67), but not the gold Mega Ball number (14). The deadline to claim the prize is **Wednesday**, **Jan. 25**, **2023**, **at 5 p.m. local time.** The ticket holder may claim the prize at any Texas Lottery[®] claim center.

The ticket holder may also claim the prize by mail. The ticket, <u>along with a claim form</u>, must be postmarked on or prior to the Jan. 25 ticket expiration date and should be mailed to:

Please allow 8-12 weeks for mail-in claims to be processed.

"We hope to celebrate the Texas Lottery player who became a \$1 million prize winner during the historic July 29, 2022 Mega Millions drawing, which featured an advertised \$1.28 billion jackpot – the second largest in game history," said Gary Grief, executive director of the Texas Lottery. "We encourage our Mega Millions players to take another look at their tickets, check the numbers again, and if your numbers match, sign the back of the ticket before claiming your prize at a Texas Lottery claim center."

A ticket holder forfeits any claim to a prize for a draw game after the expiration of the 180th day following the draw date. The deadline may be extended for a period of time for certain eligible military personnel. Unclaimed prizes revert back to the state for programs authorized by the Texas Legislature.

Another winning ticket worth \$1 million for the same drawing was sold at RaceTrac #099, located at 1100 W. Park Blvd., in Plano and was recently claimed by a Plano resident.
