

Charitable Bingo Operations Division Notice of Promotional Bingo Game

WHO MUST SUBMIT THIS FORM

This form must be submitted by a person on behalf a business conducting a bingo game for promotional or advertising purposes.

GENERAL INFORMATION

- The promotional bingo game must be conducted by or through a newspaper, radio or television station.
- Participation in the promotional bingo game must be open to the general public and not limited to customers of the business.
- A player of a promotional bingo game cannot be required to provide anything of value, including personal information beyond name and contact information, money, goods, or services in order to receive playing materials or to participate in any facet of the game.
- Playing materials for a promotional bingo game must be furnished without charge to a person on request.
- A player of a promotional bingo game cannot be required to incur conditions or obligations such as requiring a purchase, providing an interview, attending a sales seminar, or posing for a photograph in order to receive playing materials or to participate in any facet of the game.
- A person whose identification is required to be disclosed on a Texas bingo license record may not:
 - 1. be involved in the conduct of a promotional bingo game;
 - 2. have any ownership, serve on the board of directors, or have any role in the sales, marketing, or advertising of the business conducting the promotional game;
 - 3. have any ownership or serve on the board of directors of the advertising agency hired by the business conducting the promotional game or serve in any role for the advertising agency related to the sales, marketing, or advertising for the business conducting the promotional game; and
 - 4. have any ownership or serve on the board of directors of the newspaper, radio or television station assisting the business conducting the promotional game or serve in any role for the newspaper, radio, or television station related to the sales, marketing, or advertising for the business conducting the promotional game or the advertising agency.
- The commission will issue a *Recognition of Exemption Notice for Promotional Bingo Games* letter to the business conducting the exempt promotional bingo game upon verification that the applicable requirements of Section 2001.551 of the Bingo Enabling Act and Charitable Bingo Administrative Rule 402.212 have been met.
- Please note that records of the transactions connected with an authorized promotional bingo game must be maintained for a period of 4 years from the conclusion of the game.
