## FREQUENTLY ASKFD QUESTIONS

Q. Whap are the acceppable forms of paymenf for Texas Loftay itickers
A. Retailers may only accept debit cards, cash, checks or Texas Lottery-issued coupons and vouchers as payment for lottery tickets. It is a criminal offense to accept any other form of payment. Also, retailers cannot require a minimum purchase to use a debit card for lottery purchases.

A. No. Lottery tickets can never be purchased with a credit card. It is a retailer violation to do so. Penalties range from a 10-90 day license suspension or revocation for first occurrence to license revocation for third offense.
