FREQUENTLY ASKED QUESTIONS

- Q. What are the acceptable forms of payment for Texas Lottery® tickets?
- As Retailers may only accept debit cards, cash, checks or Texas Lottery-issued coupons and vouchers as payment for lottery tickets. It is a criminal offense to accept any other form of payment. Also, retailers cannot require a minimum purchase to use a debit card for lottery purchases.
- Q. If a customer is paying for other items with a credit card, can they add lottery to the transaction?
- A. No. Lottery tickets can never be purchased with a credit card. It is a retailer violation to do so. Penalties range from a 10–90 day license suspension or revocation for first occurrence to license revocation for third offense.

CREDIT CARDS ARE NEVER ACCEPTABLE FOR TEXAS LOTTERY PURCHASES.
