



**AMENDMENT NO. 9**  
*to the*  
**CONTRACT FOR INSTANT TICKET MANUFACTURING AND SERVICES**  
*between the*  
**TEXAS LOTTERY COMMISSION**  
*and*  
**SCIENTIFIC GAMES INTERNATIONAL, INC.**

**WHEREAS**, the Texas Lottery Commission (the "Commission" or "Texas Lottery") and Scientific Games International, Inc. ("the Contractor") (collectively, "the Parties") entered into a contract for Instant Ticket Manufacturing and Services with an effective date of September 1, 2012, as amended by Amendment No. 1 effective December 11, 2012, Amendment No. 2 effective November 20, 2014, Amendment No. 3 effective March 26, 2015, Amendment No. 4 effective September 21, 2015, Amendment No. 5 effective February 23, 2016, Amendment No. 6 effective August 18, 2016, Amendment No. 7 effective February 2, 2017 and Amendment No. 8 effective May 23, 2017 (collectively, the "Contract");

**WHEREAS**, pursuant to Section IV of the Contract, the Parties may by mutual agreement modify the scope, personnel and prices set forth in the Contract; and

**NOW, THEREFORE**, pursuant to Section IV of the Contract, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to amend the Contract as follows:

1. Table 1 of Contractor's Revised Sealed Cost Proposal in Amendment No. 8 is amended to add the base ticket prices in Attachment A of this Amendment for the 12 x 12 ticket size. Attachment A is incorporated by reference and expressly made a part of this Amendment No. 9 and the Contract, and shall apply during the Contract term and any renewal period.
2. Except as amended hereby, all of the terms of the Contract remain in full force and effect. All capitalized terms not specifically defined herein shall have the meaning assigned to such terms in the Contract.
3. This Amendment shall be effective upon execution by both parties.
